This is why I support these four reforms that are critical to the future of the solar industry:

1. Retain residential solar credits under Section 25D and 48E for 5+ years.
2. Remove the 60-day requirement and return to "Begin Construction" rather than introducing the new "Placed-in-Service" standard for 48E projects.
3. Match the timeline for transferability of 48E credits to credit availability.
4. Simplify FEOC rules and implement to avoid supply chain disruptions.
